- Soon to commence Mental Health Building Lobby/Reception Area & 6th Floor Improvements

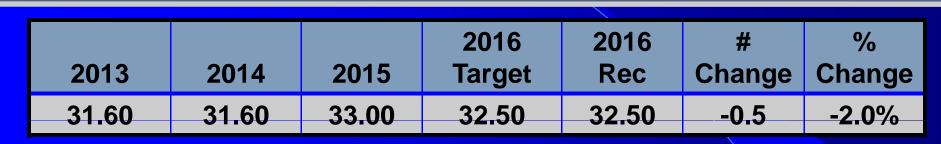


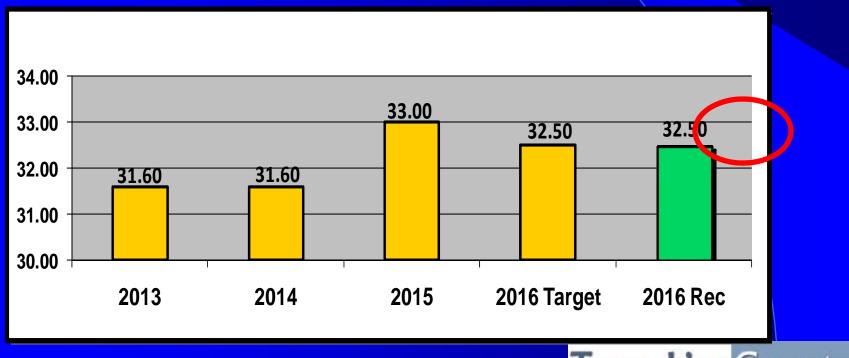

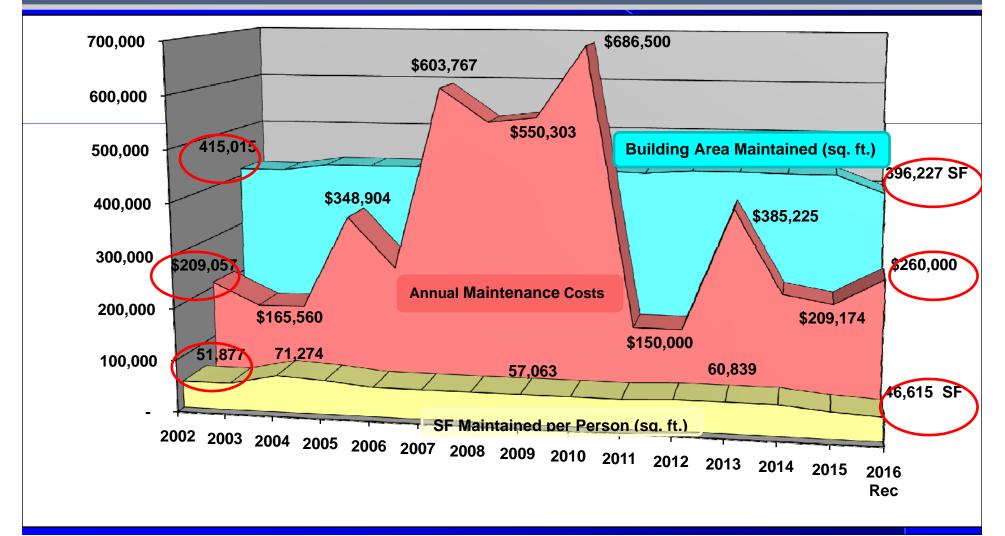


Full-Time Equivalents

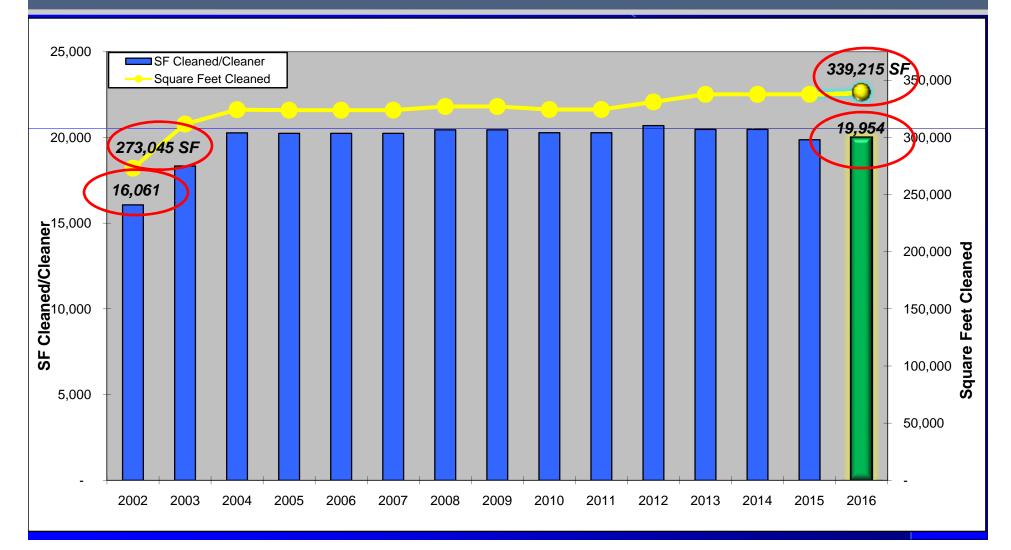




Facilities Maintenance Historical Data 2002 – 2016
