<u>AEM(Agricultural Environmental</u> <u>Management) Program</u>

- Inventory and assessment on 14 farms regarding their conservation practices
- Planning assistance for 23 acres of conservation pasture management



 Evaluation of 10 farm's implemented conservation practices

Fingerlakes Lake Ontario Watershed Protection Alliance (FLLOWPA):

- Barnyard roof cover project in Town of Caroline (\$10,000)



- Support of USGS Gauging Stations for flow monitoring on Sixmile Creek (\$5,600)
- Support of Community Science Institute's Water Quality Monitoring program (\$7,000)
 - Stormwater Management Trainings (\$3,000)
- Support of streambank stabilization along Hubbell Drive in Enfield (\$10,000)
 - Staff Salary Support (\$30,000)

- NYS Southern Tier Agricultural Industry Enhancement Program
- Increases in the Governor's 2016-2017
 Environmental Protection Fund
- Hydrilla eradication efforts
- Cayuga Lake TMDL

<u>NYS Southern Tier Ag Industry Enhancement</u> <u>Program</u>

- \$1.35 Million allocated for competitive projects between \$20,000-\$100,000 for economic improvements on farms in Tompkins County.
- <u>Round 1</u> awarded 8 out of 10 applications for a total award amount of <u>\$620,390</u>.
- <u>Round 2</u> is currently accepting applications.

<u>NYS Southern Tier Ag Industry</u> <u>Enhancement Program</u>

Projects include:

- Barn upgrades and expansions
- Value-added grain processing facilities
- Solar Panels
- Machinery and commodity storage facilities

Increases in Governor Cuomo's Environmental Protection Fund

- Competitive Funding:
 - Ag. Non-point source pollution control program (\$14.2M →\$19M)
 - NYS Soil and Water Conservation Committee Climate Resilient Farms Program (\$500,000 → \$2.5M)
 - Water Quality Improvement Program ($\$8M \rightarrow \$20M$)
- Non-Competitive Funding:
 - FLLOWPA (\$1.75M → \$2.279M)
 - Soil and Water Conservation Districts ($$5.275M \rightarrow $9 M$)

Hydrilla Eradication Efforts

- All monitoring efforts continue to show no signs of Hydrilla in Cayuga Inlet
- Trace amounts of Hydrilla still in Fall Creek near Golf Course Lagoon (4'x4') patches
- No Hydrilla detected in lake for 2016 monitoring so far. Isolated patch found in 2015 near Cornell Sailing Center.

Hydrilla Eradication Efforts

- <u>2017 Funding</u> :
 - \$60,000 from NYS Parks
 - \$225,000 from US Fish and Wildlife Service
 - This should cover all expenses for the 2017 season.

Major Influences for 2017 Budget (and Beyond)

Cayuga Lake TMDL

- State will set a limit of amount of Phosphorus entering the south end of Cayuga Lake.
- This is no longer a question of IF a TMDL will be enforced. It is a matter of WHEN a TMDL will be enforced.
- NYSDEC is looking to have this be a voluntary program rather than a regulatory approach.

Major Influences for 2017 Budget (and Beyond)


Cayuga Lake TMDL

- A TMDL will make Tompkins County more competitive in being awarded Water Quality Improvement grants
- Soil and Water will be looked at as a leader in implementation of on-theground projects to meet the TMDL limit

Justification for \$200,000 one-time OTR

- Projection of \$2.35 million in expenses in 2017 that will be <u>reimbursable</u> by grants, state, federal or "non-county" local funding.
- Projection of \$267,000 in Administrative costs that will be covered mostly by County Funding.
- This OTR would be most useful to the District as a one-time OTR that is not reimbursable to the County.
