#### Mental Health Services

- Local Government Unit Plans, develops, and funds programs and services that meet the needs of the community.
- Clinic Provides open access intake, twenty-four hour crisis services, group and individual therapy, medication therapy, and forensic therapy.
- PROS Provides community rehabilitation and support, intensive rehabilitation, ongoing rehabilitation, and clinic treatment.
- Health Homes Provides case management services to adults with severe and persistent mental illness.
  - Reentry Program Provides case management services to those who may have barriers and challenges in returning to the community after being released from Tompkins County Jail.

- Reduced Revenue Projection for Health Home






### Clinic Revenue/Expenses

#### 2018 Mental Health Association OTR

- MHA provides support groups at the County Jail and the Tompkins County Probation Services Day Reporting. These groups are led by NY State Certified Peer Specialists and/or Credentialed Family Peer Advocates. The purpose is to help reduce stress of participants, educate them about healthy choices and support resources when they re-enter the community or complete their program.
- 2018 One time funding \$24,367.20
- 2019 Included in Mental Health Target \$31,479.00

#### 2019 Initiatives

- Complete Electronic Health Record Implementation
- Review of Department Head Role
- Preparation for Value Based Payments

#### Mental Health Court

- MH Court is designated for defendants that struggle with MH issues
- Similar to Drug Court or Family Treatment Court
- Judge Scott Miller is leading the development
- In need of a part time Court Administrator
- Plan is being developed and will likely need approximately \$35,000
