Although Challenge has a reputation for supporting people with disabilities, they also serve people with other barriers. They include; (25%) development disabilities, (27%) with a mental health diagnosis, (15%) dual diagnosis, (29%) who face economic or social barriers, and (4%) with a learning disability. Areas of support include: Prevocational Services: help people to get ready for meaningful long-term community employment, Employment and Vocational Services: helping people find and thrive in jobs that suit their strengths, Social Services Programs: helping people with the legal and economic barriers to achieve self-sufficiency.
