### Introduction to the Water Resources Council

The Tompkins County Water Resources Council (WRC) advises the Tompkins County Legislature on matters related to water resources management and planning. The Council is also charged with identifying problems, proposing priorities, and promoting the coordination of activities in the management and protection of the County's water resources.

The WRC provides a public forum for local communities and stakeholder groups to address and discuss their concerns regarding water resources. It is the intent of the group to coordinate the water resources-related efforts of local governments, public and private institutions, and agencies and organizations throughout Tompkins County.

### **Frequently Asked Questions**

The public is welcome to attend WRC meetings, which take place the third Monday of the month at 4:15pm with the exception of federal holidays. Tompkins County residents are invited to apply to become voting members.

WRC membership consists of 21 voting members appointed by the Tompkins County Legislature. These members represent various water-related interests and serve on a number of standing and special committees. There are also seats for non-voting ex-officio and associate members.

### **Executive Committee**

In 2020 the Executive Committee wrote several letters in support of WRC committee goals and objectives, as well as letters of support to County, State and Federal authorities.

In January, to further the work of the Water Withdrawals Committee and its objective to gather information about water withdrawal permit requests, the Executive Committee wrote to the New York State Department of Environmental Conservation as well as the Susquehanna River Basin Committee, requesting that "notification of all major and minor water-withdrawal permit applications or modifications of an existing permit in Tompkins County, NY be sent to the Chair of the WRC via the TC Department of Planning and Sustainability."

In July, the Executive Committee wrote to the NYS Department of Health expressing its support for a statewide municipal wastewater coronavirus surveillance system. By tracking the levels of coronavirus RNA in New York's municipal wastewater, the committee argued, a surveillance system may be able to provide advanced warning of increasing coronavirus transmission in densely populated areas and subsequent surges in confirmed cases and hospitalizations. Conversely, a wastewater surveillance system may also help localities identify areas where the virus is waning or absent.

In September, the Executive Committee authorized a letter requesting the reinstatement of financial support to the greatest extent practicable for the Community Science Institute's (CSI) stream monitoring program. The WRC is charged with identifying problems, proposing priorities, and promoting the coordination of activities in the management and protection of the County's water resources. The services provided to the County by CSI are integral to the furtherance of our work.

#### 2020 Accomplishments


